Reference your Application No. MOEAF/R/2018/00371 dated 20/4/2018, seeking information under Right to Information Act 2005.

2. Our reply is given below :

Diplomatic Missions do not come under the purview of RTI Act, 2005. Hence, information cannot be sought from the Chinese Embassy in this regard under the RTI Act. Ministry of External Affairs grants permission to the Diplomatic Missions to sell their vehicles in the open market. After getting this permission Diplomatic Missions are free to sell their vehicles in the open market. Name of the buyer is not required while granting sale permission to the Diplomatic Missions. Permission to sell the vehicle (Nissan AD Wagon, Model 1999, Regn. No.17CD79 Chasis No. JN1TDAY102003540, Engine No.GA16618282 belonging to Mr. Sheng Fengxue, former First Secretary in the Chinese Embassy) in the open market was granted by the Ministry of External Affairs, Protocol Division on 14 November 2013.

4. In case the applicant is not satisfied with the response given by the undersigned, the applicant may file an appeal within 30 days of the receipt of this communication to Shri Sanjay Verma, Chief of Protocol and First Appellate Authority, Room No. 2001, Jawaharlal Nehru Bhawan, Ministry of External Affairs, 23D, Janpath, New Delhi-110011.


