



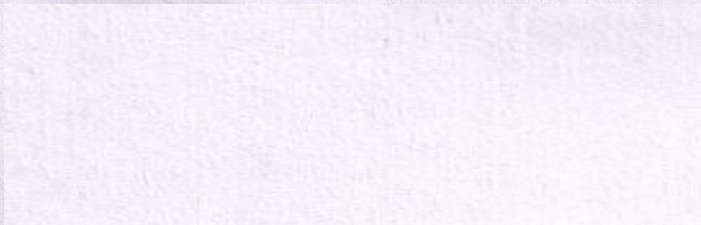

Please refer to your RTI application bearing Registration No. MHOME/R/X/20/00160 dated 04 May 2020, No. MHOME/R/T/20/01264 dated 5 May 2020, No. MHOME/R/T/20/01229 dated 30 April 2020, No. MHOME/R/X/20/00159 dated 4 May 2020 seeking information under RTI Act, 2005.

2. Only point no. 1 of your query pertains to the undersigned CPIO. Information with respect to point no. 1 is as follows:

The Government of India organized three special flights on 31 January 2020, 1 February 2020 and 26 February 2020 to evacuate 766 persons, which included 723 Indian nationals and 43 foreign nationals from the city of Wuhan as well as other cities of Hubei Province in China in view of the continuing lock down of the Hubei Province.

3. The above question has also been answered in a Parliamentary Q & A by Ministry of External Affairs which is enclosed for your reference.

4. If you are aggrieved with this reply, you may file an appeal to Dr. Amit Telang, Director(East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi -110001, within a month from the date of receipt of this letter.

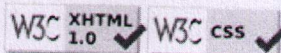
(a) to (c) The Government of India organized three special flights on January 31, February 1 and February 26 to evacuate 766 persons, including students from the city of Wuhan as well as other cities of Hubei Province

in China in view of the continuing lock down of the Hubei Province because of the Coronavirus there.

As conveyed by External Affairs Minister in the Rajya Sabha on 7 February 2020, at the time of our flights, it had been indicated to the larger community in Wuhan that in addition to bringing back Indian nationals, we would also like to bring back people of our neighbouring countries who would like to come back.

The evacuated persons included 723 Indian nationals and 43 foreign nationals. The foreign nationals included 23 from Bangladesh, 9 from Maldives, 2 from Myanmar, 1 from South Africa, 1 from Madagascar and 1 from United States of America who was a partner of an Indian national. In addition, 6 Chinese citizens who were spouses and/or children of Indian nationals were also evacuated.
