3. The following is the response of the CPIO:

It may be noted that as per our records this number has not been allotted by the Ministry of External Affairs, Protocol Special Section. Further, this number prime facie appears fake as this is not the prescribed format of registering UN vehicles. You may like to approach the concerned Motor Licensing Officer (MLO) in Bangalore to further check the authenticity of this number as vehicles belongs to UN offices outside New Delhi are registered by MLO in the concerned State.

In case the applicant is not satisfied with the response given by the undersigned, the applicant may file an appeal within 30 days of the receipt of this communication to Shri Sanjay Verma, Chief of Protocol and First Appellate Authority, Room No. 2001, Jawaharlal Nehru Bhawan, Ministry of External Affairs, 23D, Janpath, New Delhi-110011.
