Please refer to your RTI application dated 29 December 2018 addressed to RTI Cell, Ministry of External Affairs, New Delhi, received by this Division on 29 December 2018 vide reference no. MOEAF/R/2018/51499/1.

2. The information pertaining to the undersigned CPIO is as follows:

China is under occupation of approximately 38,000 sq. Kms of Indian territory in the state of Jammu & Kashmir. In addition, under the so-called China-Pakistan "Boundary Agreement" signed between China and Pakistan on 2 March 1963, Pakistan illegally ceded 5,180 sq. kms. of Indian territory in Pakistan Occupied Jammu & Kashmir to China.

The fact that Jammu & Kashmir is an integral and inalienable part of India, has been clearly conveyed to the Chinese side on several occasions, including at the highest level.
