Deputation of a Medical expert to Mauritius under ITEC Subject:

(Indian Technical & Economic Cooperation) programme

Indian Technical and Economic Cooperation (ITEC) Programme of Ministry of External Affairs is a flagship program for capacity building of friendly foreign countries. One of the activities under the ITEC Programme is the deputation of experts to partner countries, based on their requirements.

- 2. We are under receipt of a request from the Government of Mauritius for deputation of a medical expert who could function as the Director General of Health Services. The expert will head the professional and technical sections of the Mauritian Ministry of Health and coordinate and implement their health policies and programmes.
- 3. The expert is to be deputed under ITEC programme of this ministry under which Ministry of External Affairs bears expenses towards pay, foreign allowance, transportation of personal effects, air fare etc while the Government of Mauritius will take care of accommodation, medical coverage, local transportation.
- In this regard, MoH&FW is requested to kindly nominate a 4. suitable medical expert meeting the eligibility criteria, experience, job description etc. along with the proforma as laid in the attached Annexure, positively before 30 days from the date of issue of this letter.
