The Government has been making efforts for the promotion of Hindi as an official language of the United Nations (UN) and its propagation worldwide. Indian leaders have delivered statements at the UN in Hindi, including Prime Minister's statement at the 69th UN General Assembly (September 2014), 74th UN General Assembly (September 2019) and at the UN Sustainable Development Summit (September 2015).

Government of India signed a MoU with the UN Secretariat in March 2018 for increasing the volume and frequency of Hindi content produced by the UN to serve Hindi language audiences around the world. As part of this MoU, in July 2018, UN launched Hindi versions of its social media content on Twitter, Facebook and Instagram. Hindi website of UN News was initiated on the occasion of World Hindi Day in January 2019. The UN News audio bulletins in Hindi (UN Radio) are being released on a weekly basis.
