Please refer to your RTI application dated NIL addressed to the undersigned CPIO, which was received through Central Registry on 13/7/2017.

2. The information sought by you is as follows:


India and China have agreed to each appoint a Special Representative (SR) to explore the framework for a boundary settlement from the political perspective of the overall bilateral relationship. There have been nineteen meetings of SRs so far, last one being in Beijing on 20-21 April, 2016. The two sides agree that peace and tranquility in the border areas is the basis for the continued expansion of India-China relations.

Various issues relating to trans-border rivers are discussed with China under the ambit of India-China Expert Level Mechanism which was established in 2006. 10th meeting of the ELM was held in New Delhi in April 2016. Under respective Memoranda of Understanding signed between the two countries, China provides hydrological data during flood season for Brahmaputra and Sutlej River to India.

3. The information sought by you regarding "China's historical status on Tibet conveyed to India officially" is exempted under Section 8 (1) (a) of the RTI Act, 2005.

4. If you are aggrieved with this reply, you may file an appeal to Shri Sujit Ghosh, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.

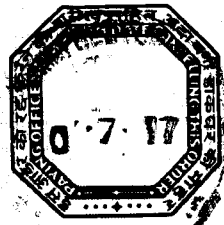
