2. The information pertaining to the undersigned CPIO is as follows:

There is no commonly delineated Line of Actual Control (LAC) in the border areas between India and China. From time to time, on account of differences in the perception of the LAC, situations have arisen on the ground that could have been avoided if we had a common perception of the LAC. Government regularly takes up such situations along the LAC with the Chinese side through established mechanisms including border personnel meetings, flag meetings, meetings of Working Mechanism for Consultation & Coordination on India- China Border Affairs and diplomatic channels.

3. If you are aggrieved with this reply, you may file an appeal to Shri Sujit Ghosh, Director (East Asia) & Appellate Authority, Ministry of External Affairs, South Block, New Delhi – 110011, within a month from the date of receipt of this letter.
