2. List the various gifts presented by the Honourable Prime Minister of India to the visiting nation during his above mentioned international diplomatic visits and mention the name of the persons to whom the gifts were contributed

3. Provide a detailed explanation about such gifts both received and presented by the Honourable Prime Minister of India during his above mentioned international diplomatic visits and its significance in Strengthening the bilateral relation of the two countries

4. Provide the information on the amount of Rupees spent by the Government of India for such gifts presented by the Honourable Prime Minister of India to the visiting nations during his above mentioned international diplomatic visits.

The following is the response of the CPIO: 3.

In this connection, this is to state that the Prime Minister of India 2,3 &4. presents gifts, as per the laid down norms, to various foreign dignitaries. Information sought by you relates to, among other things, the type/cost of the gifts presented during the period mentioned above. It is true that the procurement of gifts is being met from budgetary grants but the revelation of the information sought would have unintended effects on the foreign relations and that any critical analysis/scrutiny and comparison between quantum and value of the gifts would be totally undesirable and would defeat the very purpose of generating goodwill between the nations. However, disclosure of this information may prejudicially affect India's relations with the concerned foreign State. Exemption is therefore, sought under section 8(1) (a) of the RTI act 2005, wherein no such information as may prejudicially affect India's relations with a foreign State need be disclosed.

4. In case you are not satisfied with the above reply, you may appeal within 30 days to the Appellate authority in this Ministry at the following address: Joint Secretary (COP)/Appellate Authority, Room No. 149 A, South Block, New Delhi 110011.


