Sir,

Please refer to your RTI applications dated 30.1.2014, seeking details of the expenditure incurred on the visit of US President Mr. Barack Obama. Our reply is given below ad seriatim:

(1) & (2) This is to state that the information does not exist as records mentioned under these points are not maintained by the undersigned CPIO.

(3) In this connection, this is to state that the Prime Minister of India presents gifts, as per the laid down norms, to various foreign dignitaries. Information sought by you relates to value/cost of the gifts presented by the PM to the US President and family. However, disclosure of this information may prejudicially affect India's relations with the concerned foreign State. Exemption is, therefore, sought under section 8(1) (a) RTI act 2005, wherein no such information as may prejudicially affect India's relations with a foreign State need be disclosed.
