Subject: Request For Proposal (RFP) for selection of an IT company for design, development, hosting, updation of a new website for Pravasi Bharatiya Divas (PBD) Convention and its maintenance.

In partial modification of the RFP bearing Tender id. 2026_MEA_893685_1 dated 02.02.2026, the following amendments may kindly be noted:

Request for Proposal (RFP):

- **Title:** Request For Proposal (RFP) for selection of an IT company for design, development, hosting, updation of a new website for Pravasi Bharatiya Divas (PBD) Convention and its maintenance.
- **Turnover (Para 6.1.3):** The Bidder's turnover should be more than ₹ 75,00,000/- (Rupees Seventy Five Lakh Only) average over the last five years among FYs viz., 2021-22, 2022-23, 2023-24, 2024-25 and 2025-26. A certificate to this effect from Chartered Accountant must be submitted. In case of MSMEs/ Startups/ SHGs, the quantum of turnover per annum will be relaxed to the extent of ₹ 49,00,000/-. The turnover should be specifically for the field of 'Information Technology Professional Services/IT Consultation and Software Support Services'.
- **BOQ Point 1.02** may be read as 'Annual Charges for security audit (through CERT-IN empanelled agencies as per RFP) + Annual Hosting Charges.'
- Subsequently the Estimated bid value due to incorporation of hosting charges now stands at ₹ 1,05,00,000/- (₹ One Crore Five Lakhs only) instead of the earlier estimated bid value of ₹ 70,00,000/- (₹ Seventy Lakhs only).
