3.	Period of Consultancy	:	<b>01 (One) year</b>  The contract can be extended further depending on assessment of performance, mutual willingness and the requirement. The contract may be terminated on one month's notice from either side or on payment of one month's pay in lieu thereof. Unauthorized absence may lead to termination of the engagement.

Nature of Duties	:	<ul style="list-style-type: none"><li>• The selected consultant will be required to work as domain expert on International Relations and Policy in the Policy Planning and Research Division of the Ministry.</li><li>• His/Her duties will entail preparation of briefs, reports, analysis of historical trends and latest developments in geopolitics, geoeconomics, geotechnology and geostrategy and in domains such as international law, climate diplomacy, cultural and public diplomacy, international trade and economy, conflict studies, multilateral diplomacy, digital diplomacy and all areas of specialisation related to international relations.</li><li>• His/Her duties will entail generation of content on Foreign Policy related issues and provide knowledge-based inputs for the same.</li><li>• He/She will be required to summarize and analyse published material in the areas assigned to them, as it appears in media or academic journals.</li><li>• He/She will be required to review and vet articles, reports, policy documents prepared by the existing Consultants to ensure that the work undertaken by them aligns with MEA's strategic priorities and research standards.</li><li>• He/She will be required to attend seminars and conferences relevant to the work of the Policy Planning and Research Division and submit reports on them.</li></ul>

Normal working hours will be from 0900 to 1730 hrs. Working hours is subject to change from time to time. Saturdays/Sundays will remain closed as weekend off. In exigencies, he/she may be required to work beyond office hours and/or on holidays. No extra allowance or remuneration for such work is admissible. He/She shall not accept any other professional appointment, paid or otherwise in government or private sector or in any other organization of any kind during the term of engagement with this Ministry.</li> <li>• Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service.
