			<ul style="list-style-type: none"> <li>• Experience in diaspora outreach programmes and managing conferences.</li> <li>• Candidate must be in a minimum of 25 years of age and maximum age should be 50 years on the last date of submission of applications. Preferences will be accorded to those in the age gap of 25-35 years.</li> </ul>
6.	Desirable Qualifications	:	<ul style="list-style-type: none"> <li>• Excellent proficiency in both written and spoken English.</li> <li>• Proficient in MS Office. Good command of English language. Excellent writing and communication skills.</li> <li>• Familiarity with design software and technologies (such as InDesign, Illustrator, Dreamweaver, Photoshop, Canva).</li> <li>• Knowledge of Wordpress, content management systems and designing and management of website.</li> <li>• Proficiency with photo editing software.</li> </ul>
7. He/She shall not accept any other professional appointment, paid or otherwise in government or private sector or in any other organization of any kind during the term of engagement with this Ministry.</li> <li>• Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed. Leave cannot be claimed as a matter of right. Leave will not be allowed for more than 10 days at a time.
