2.	Period of Consultancy	:	Initially for 01 (one) year The contract can be extended further depending on assessment of performance, mutual willingness and depending on the requirement. The contract may be terminated on one month's notice from either side or on payment of one month's pay in lieu thereof. Unauthorized absence may lead to termination of the engagement.

Applicant for the above position must have an LLB and may have LLM degree from a recognized university in India or abroad with Immigration/Emigration law as one of the subjects. Extra credit will be given to retired officials of GoI with Emigration law experience/background. Officials who have worked on drafting and legislative procedures. Work experience 5-10 years. Age criteria 28-61 years.
6.	Desirable Criteria	: <ul style="list-style-type: none"> Previous experience of handling issues relating to Emigration Law, draft of Legislation and research experience in the field.
7.	Remuneration &Entitlements	: <ul style="list-style-type: none"> The remuneration package will be commensurate with the experience and profile of the selected candidate, subject to a maximum of Rs. 10 lakh per annum and deduction of applicable taxes. The consultancy fees shall be paid in Indian Rupees. The amount of consultancy fee so fixed shall remain unchanged during the term of engagement. The remuneration in case of retired Government of India officials will be governed as per the prevailing

Normal working hours will be from 0900 to 1730 hrs. Working hours is subject to change from time to time. Saturdays/Sundays will remain closed as weekend off. In exigencies, he/she may be required to work beyond office hours and/or on closed holidays. No extra allowance or remuneration for such work is admissible. He/She shall not accept any other professional appointment, paid or otherwise during the term of engagement with this Ministry.• Paid leave of absence may be allowed to the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed. Leave cannot be claimed as a matter of right. Leave will not be allowed for more than 10 days at a time.
