2. Has there been any formal acknowledgment or acceptance by the Government of India regarding the ceding of Indian territory in Ladakh and Galwan Valley to China? If yes, please provide copies of relevant

documents or correspondence.

3. What steps has the Government of India taken, if any, to address the issue of the alleged ceding of Indian territory in Ladakh and Galwan Valley? Please provide a detailed account of any diplomatic, legal, or administrative actions taken in this regard.

4. Are there any ongoing negotiations or discussions between the Government of India and the Government of China regarding the territorial dispute in Ladakh and Galwan Valley? If so, please provide information on the status and progress of these negotiations.

5. Lastly, under which legal provisions or policies does the Government of India operate concerning territorial disputes and cessions, particularly in the context of Ladakh and Galwan Valley?

I request the information to be provided in writing, preferably in the form of certified copies of relevant documents or official responses. Kindly adhere to the statutory timelines prescribed under the Right to Information Act, 2005, for providing the requested information.
