<u>CIRCULAR</u>

It is proposed to fill one post of Director in the Library & Information Cadre of the Ministry of External Affars on deputation basis for a period of three years initially from amongst officers holding analogus posts on a regular basis in the parent cadre or department; or Officers with five years' regular service in posts in Level 12 in the Pay Matrix Rs. 78800-209200 or equivalent, working in Central Government orState Government or Union Territories or Autonomous or Statutory Organisation or Public Sector Undertakings or University or Recognised Research Institutions; and possesing the following educational qualifications and experience:-

Educational Qualification:-

a) Essential:-

I) Master's Degree in Library Science or Library and Information Science from a recognised University or Institute;

II) Ten years' experience in a Library under the Central Government or State Government or autonomous or statutory organisation or public sector undertaking or University or recognised research or educational institution.

b) Desirable:-

(i) One year experience of computerising library activities in a Library under the Central Government or State Government or autonomous or statutory organisation or public sector undertaking or University or recognised research or educational institution; or

(ii) One year experience of indexing, abstracting and retrieval of documents or information using library management software; or

(iii) Diploma in Computer Application from a recognised University or institute; or

(iv) Certificate course of six months duration in one or two foreign languages other than English from a recognised University or Institute.

2. The period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed five years. The maximum age-limit for appointment by deputation (including short term contract) shall be not exceeding fifty- six years as on the closing date of receipt of applications.
