## **CIRCULAR**

Subject: Filling up of the post of Library & Information Officer (LIO) in Level 11 in the Pay Matrix on deputation basis in the Library & Information Cadre of the Ministry of External Affairs.

It is proposed to fill one post of Library & Information Officer (LIO) in the Library & Information Cadre of the Ministry of External Affars on deputation basis for a period of three years initially from amongst officers holding analogus posts on a regular basis in the parent cadre or department; or with seven years regular service in posts in level 7 in the pay matrix Rs.44900-142400, working in Central Government or State Government or Union Territories or Autonomous or Statutory Organisation or Public Sector Undertakings or University or Recognised Research Institutions; and possesing the following educational qualifications and experience:-

#### **Educational Qualification:-**

### a) Essential:-

- I) Masters Degree in Library Science or Library and Information Science from a recognised University or Institute;
- II) Five years' professional experience in a Library under Central Government or State Government or autonomous or statutory organisation or public sector undertaking or University or recognised research or educational institution.

#### b) Desirable:-

- (i) One year experience of computerising library activities in a library under the Central Government or State Government or autonomous or statutory organisation or public sector undertaking or University or recognised research or educational institution; or
- (ii) One year experience of indexing, abstracting and retrieval of documents or information using library management software; or
- (iii) Diploma in Computer Application from a recognised University or Institute; or
- (iv) Certificate course of six months duration in one or two foreign languages other than English from a recognised University or Institute.
- 2. The period of deputation (including short term contract) including the period of deputation (including short termcontract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed four years. The maximum age-limit for appointment by deputation (including short term contract) shall be not exceeding fifty-six years as on the closing date of receipt of applications.

- 3. It is requested that above-mentioned requirement may please be circulated / advertised to the entire field / sources, including Attached/Subordinate Offices (amongst all the eligible officers of various Ministries/ Departments) concerned. Interested applicants may send their applications through proper channel in the enclosed proforma, in duplicate, to the undersigned within a period of 2 months from the date of publication of this circular in the Employment News. Applications received after the last date or otherwise incomplete shall not be considered.
- 4. Pay of the selected officers shall be fixed in the scale of the post in accordance with rules prescribed by the Government.
