**Points No. 1-3:** Request for political clearance for visit by Shri Kadakampally Surendran, Minister for Tourism, Government of Kerala to China from 11-16 September 2017 to attend the 22<sup>nd</sup> Session of the United Nations World Tourism Organization (UNWTO) General Assembly was received in Ministry of External Affairs on 23 August 2017. Requests for clearance from political angle are examined in the Ministry of External Affairs as per guidelines issued by Cabinet Secretariat and other relevant entities from time to time. Ministerial level participation at the aforementioned event was not deemed appropriate in national interest.

Points No. 4: Not available with the undersigned CPIO.

Therefore, Point No. 5 of your RTI application is hereby being transferred to Under Secretary (Coordination) in the Parliament and Coordination Division of the Ministry of External Affairs.

Mr. Kadakampally Surendran had applied for a diplomatic passport for the same, his request was rejected by the Ministry of External Affairs of the Government of India. Surendran was denied permission take part in the meeting hosted by China.

4. Provide copy of the letter sent by the Chief Minister of Kerala, Mr. Pinarayi Vijayan and Mr. Kadakampally Surendran expressing their protest to the denial of clearance to the Prime Minister and External Affairs Minister. Along with copy of replies if any, sent by them or the ministries.

5. Provide the copy of document which shows the names of the Ministers from various State and Union Ministers who were given clearance to travel abroad for official and private purposes separately, till date from date on which the Present Ruling Government came into power. Along with the amounts spent by the Government of India so far for the above mentioned foreign trips.
