Reference to the letter from former US, (Welfare) Shri.P.C Thapliyal, vide MEA's ID No. Q/Wel/851/11/2014. It had called 49 candidates against 9 vacancies (1)LDC & (8)MTS for an interview in recruitment year 2014-15 on 6th of May, 2015. (enclosed)

It is requested to provide me the following information under aforesaid act.

1. A complete list of candidates/dependents who are eligible and their case is to be consider for employment under "The Scheme for Compassionate Appointment, 1998", from both type of cases, whose parents/spouser died while in service & retired on medical grounds with their (i) Size of the family, (ii) Applicant's educational qualifications & DOB, (iii) For which post they have applied, (iv) Total numbers of abroad mission/postings had done by their parents/spouses, (v) Either date of retirement on medical grounds of Govt servant and D.O.D, (vi) State whether their monthly pension are under above Rs.18,000 p.m or not, (vii) And whether they are occupying Govt. accomodation or not.

Under the instructions contained in DOP&T's OM 14014/02/2012-Estt.(D) dated 10/01/2013 furnish me a list of candidates whose case has been closed due to completion of previous three or five years time limit as provided in DOP&T OM dated 05/05/2003. (B) Are there is any such candidate/s who are still considering for job under the any instruction/OMs/Circulars with the newly opened cases? If yes then, provide me a list of such candidates.

3. Does the Central Government's recently announced "The Special Recruitment Drive for Person with Disabilities", are also applied on the compassionate appointment scheme? If it is then, What benefits can be given to those candidates?

4. According to DOP&T's OM 39020/09/2015/Estt-B there will be no interview conducted (from 1st Jan, 2016 onwards) while making appointment at Group C & D posts in all Ministries/Departments of Govt of India. It is therefore, requested to clarify/provide information about what would be the selection procedure for appointing on compassionate grounds.

5. Kindly inform me that, After the death of a Govt. servant (while in service) what are the initial actions that should be done by S.O (Welfare) of the Ministry in order to provide relief to those families.

6. The total number of Group C & D vacancies provided by the Cadre Cell of this ministry of recruitment year 2015-16 (Current Year).
