

India-Poland Relations

I. Political Relations

India & Poland share a long-standing friendly relationship, marked by high level political contacts and vibrant economic engagement. Diplomatic relations were established in 1954, leading to the opening of the Indian Embassy in Warsaw in 1957. The two countries shared common ideological perceptions, based on their opposition to colonialism, imperialism and racism. During the Communist era, bilateral relations were close and cordial, with regular high level visits (several VVIP visits from India – beginning with Pandit Jawaharlal Nehru in 1955 - and four from Poland), coupled with planned trade and economic interactions by state trading organizations, underpinned by the rupee clearing arrangements.

The relationship continued to remain close after Poland chose the democratic path in 1989. India and Poland transitioned to hard currency trading arrangements that were sustained by rising levels of trade as both economies grew in size and heft. A cordial political relationship has emerged in the current century, particularly after Poland joined the EU in 2004, and became India's key economic partner in Central Europe.

Visits: Over earlier decades, India and Poland have had robust exchanges at the level of Heads of State and Government. High level visits from India to Poland include: Presidents V.V. Giri (1970), Zail Singh (1986), S.D. Sharma (1996) and Prime Ministers Jawaharlal Nehru (1955), Indira Gandhi (1967) and Morarji Desai (1979). From the Polish side, high level visits include: Presidents Alexander Kwasniewski (1998), Lech Walesa (1994 and 1998), Prime Ministers Cyrankiewicz (1957) and Jaroszewicz (1973), Polish United Workers' Party First Secretary Gierek (1977) and Gen. Jaruzelski (1985) and Polish PM Leszek Miller (2003). The President of India, Smt. Pratibha Patil, visited Poland in April 2009, and Polish PM Donald Tusk paid a state visit to India in September 2010. Vice President of India, Shri M. Hamid Ansari visited Poland in April, 2017. Krzysztof Szczerski, Secretary of State and Chief of the Cabinet of the President of the Republic of Poland visited India in January 2019. EAM Dr S. Jaishankar visited Poland from 28-29 August 2019. Deputy Foreign Minister of Poland Marcin Przydacz visited India in September 2019 to inaugurate the launch of direct flights from Warsaw to Delhi. The then FM Zbigniew Rau visited India from 25-27 April 2022 to take part in the Raisina Dialogue. In the margins of the Raisina Dialogue, he also called on PM and met EAM. Secretary of State for Foreign Affairs W.T. Bartoszewski visited India from 19-23 February 2024 to meet MoS Meenakshi Lekhi and then Deputy NSA Vikram Misri. He also participated in the 9th edition of the Raisina Dialogue 2024. Prime Minister of India Shri Narendra Modi paid a historic visit to Poland in August 2024. Secretary of State for Digital Affairs Michal Gramatyka visited India on 15-16 October 2024 to attend the World Telecommunication Standardization Assembly 2024 Conference held in New Delhi. Secretary of State for Foreign Affairs W.T. Bartoszewski visited India to participate in the 2025 Edition of the Raisina Dialogue held in New Delhi. Mr Rafal Rosnicki, Under Secretary of State, Ministry of Digital Affairs visited India in November 2025 to participate

in the Bengaluru Tech Summit and later in February 2026 for the AI Impact Summit in Delhi. Polish Dy. Prime Minister & Foreign Minister Radoslaw Sikorski visited India and met with EAM Dr. S. Jaishankar in Delhi on 19 January 2026. Secretary of State Mr. WT Bartoszewski visited India to participate in the India-EU Forum in February 2026. Ms. Pooja Kapur, Additional Secretary (NE), MEA visited Warsaw in March 2026 to hold bilateral consultations with Poland. During her visit, Ms. Pooja Kapur also met with Secretary of State Mr. W T Bartoszewski on 25 March 2026 in Warsaw.

Visit of Prime Minister to Poland: Prime Minister Shri Narendra Modi paid an official visit to Poland on 21-22 August 2024 on the occasion of the 70th anniversary of the establishment of diplomatic relations between India and Poland. PM's visit was historic as this visit of an Indian Prime Minister to Poland took place after 45 years. Prime Minister held discussions with PM Donald Tusk in restricted and delegation-level formats. PM also called on President Andrzej Duda of Poland in a tete-a-tete format and held delegation level talks with him. The principal outcome of the visit was the decision to elevate the India-Poland bilateral relations to the level of a Strategic Partnership. Joint Statement on the bilateral partnership and Action Plan (2024-2028) to implement the future Strategic Partnership were issued during the visit. PM paid homage to the Dobry Maharaja Memorial, Kolhapur Memorial, Monte Cassino Memorial on 21 August 2024 and at the Tomb of the Unknown Soldier in Warsaw on 22 August 2024. He also interacted with Polish business leaders, Indologists, influencers and addressed the Indian Community in Poland during the visit. Prime Minister announced the launch of a Jamsaheb Youth Exchange Programme wherein Government of India will arrange the visit of 20 Polish youth to India including to the Balachadi and Valivade camps in Jamnagar and Kolhapur.

Visit of Vice President to Poland: The then Vice President, Shri Hamid Ansari, paid an official visit to Poland in April 2017, leading a high-level delegation, including Shri Giriraj Singh, Minister of State for Micro, Small and Medium Enterprises and four Members of Parliament from both Houses – Shri Sita Ram Yechuri, Shri D.P. Tripathi, Shri Vivek K. Tankha and Shri Thupstan Chhewang. During the visit, the Vice President held extensive talks with the Prime Minister, President and the Marshal (Speaker) of the Senate (Upper House). The Vice President addressed, jointly with the Polish Prime Minister, an Indo-Polish Business Summit at the Ministry of Economic Development in Warsaw. He also formally inaugurated the newly-built Embassy complex in Warsaw. During the visit, an agreement on cooperation in agriculture and allied sector was signed. The VVIP visit, after a gap of nine years, helped to greatly reinvigorate the warm bilateral ties between India and Poland.

Visit of EAM to Poland: EAM Dr S. Jaishankar visited Poland on 28-29 August 2019. The last visit by a Minister of External Affairs was in 1987. EAM held delegation level talks with his Polish counterpart Foreign Minister Jacek Czaputowicz, which was followed by joint address to the local media. A Joint Statement was issued at the end of the visit, wherein

Poland emphasized India's role as a prominent regional power, an active and significant player in G20 and in the United Nations, as well as its key partner in South Asia. India emphasized Poland's role as an important member of the European Union and a leader of Central & Eastern Europe. EAM also met with Prime Minister Mateusz Morawiecki, and Deputy Prime Minister Piotr Glinski.

Visit of Undersecretary of State Marcin Przydacz to India in September 2019 - LOT flight inauguration: Marcin Przydacz, Under Secretary of State visited India in September 2019 on the occasion of inauguration of LOT Polish Airlines' direct flight on the Warsaw – Delhi sector. During the visit, he met with MoS(IC) for Civil Aviation Shri Hardeep Singh Puri and discussed possibility of creating a broader network of air connections in the future and also informed about plans of Poland to build the Solidarity Transport Hub (CPK) in Poland. He also had a fruitful meeting with Secretary (ER).

Agreements: A number of bilateral agreements are operational that include: Agreement on Cultural Cooperation (1957); Agreement on Avoidance of Double Taxation (1989); Agreement on Cooperation in Science and Technology (1993); Protocol on Foreign Office Consultations (1996); Agreement on Cooperation in Combating Organized Crime and International Terrorism (2003); MOU on Defence Cooperation (2003); Extradition Treaty (2003); Agreement on Economic Cooperation (2006); Agreement on Cooperation in the field of Healthcare and Medical Sciences (2009); Agreement on Cooperation in the field of Tourism (2009); Agreement on audio-visual co-production (2012); Protocol on amending the agreement on avoidance of double taxation and the prevention of fiscal evasion with respect to taxes and income (2013); Agreement on exemption from visa requirement for holders of diplomatic passports (2015); Agreement on cooperation in agriculture and allied sectors (2017); Cooperation in the area of Coal Mining (2019); Mutual Legal Assistance Treaty in Criminal Matters (2022) and Agreement on engagement in the gainful occupation by family members of a member of a diplomatic mission or consular post (2022). India-Poland Social Security Agreement and Administrative Arrangement to the Social Security Agreement was signed on 25 November 2024 in Warsaw.

Parliamentary Exchanges: Contacts between the Indian and Polish Parliaments were established after the overthrow of the Communist system in 1989. Polish parliamentary delegations have visited India in December 1992, March 2000, January 2003 and December 2004. Speaker of Lok Sabha, Shri Manohar Joshi, led a multi-party Parliamentary delegation to Poland in May 2002. Following the last general elections in October 2023, a 22-member Parliamentary Friendship Group has been constituted on 27 June 2024 with Ms. Kinga Gajewska, MP as its President. A delegation of Polish MPs led by Mrs. Dorota Niedziela,

Deputy Speaker of the Sejm including Secretary of State Mr. W.T. Bartoszewski, visited Jaipur from 8-11 December 2024 for a business and investment summit titled Rising Rajasthan. On the sidelines of the conference, the Polish MPs interacted with Speaker of the Lok Sabha Mr. Om Birla, Commerce and Industry Minister Mr. Piyush Goyal and Culture & Tourism Minister Mr. G. S. Shekhawat. A 6-member group of Polish MPs led by Mr. Pawel Kowal, Chairman of the Foreign Affairs Committee of the Sejm (lower House of Polish Parliament) visited India from 7-13 February 2025 for bilateral interactions. During the visit, the delegation of Polish MPs met with Mr. Pabitra Margherita, MOA(EA); Dr. Shashi Tharoor, Chairman, Standing Committee on External Affairs and Mr. Harivansh, Deputy Chairman of the Rajya Sabha in New Delhi. In order to strengthen India's legislative engagement with Poland, the Lok Sabha constituted India-Poland Parliamentary Friendship group in February 2026 which is headed by Hon'ble MP Mr. Surendra Singh Nagar.

Foreign Office Consultations: Both sides have been regularly engaging in Foreign Office Consultations (FOCs) since 1996. On 6 December 2024, India and Poland held Bilateral Consultations at Director General-level in New Delhi between Mr. Arun Kumar Sahu, Additional Secretary (Central Europe), MEA and Mr. Wojciech Zajczkowski, Director, Asia-Pacific Department, MFA Poland. The 11th round of Foreign Office Consultations between India & Poland was held in New Delhi on 1 December 2025. The meeting was co-chaired by Mr. Sibi George, Secretary(West), MEA and Mr. W.T. Bartoszewski, Secretary of State, MFA Poland. Both sides reviewed the entire gamut of bilateral relations, particularly the India-Poland Strategic Partnership with reference to the Action Plan (2024-2028) agreed to by both Governments during the visit of Prime Minister Shri Narendra Modi to Poland in August 2024. Both sides reaffirmed their commitment to bolster cooperation in the areas of digital payment systems, cyber security, trade and investment, AI, security and defence, culture and higher education, consular issues and people-to-people ties.

Policy Planning Dialogue

The second India-Poland Policy Planning Dialogue was held in Warsaw on 18 February 2025 between delegations led by Mr. S. Raghuram, Joint Secretary(PP&R), MEA and Mr. Lukasz Pawlowski, Director (Strategy), MFA. The first India-Poland PPD was held in a virtual mode on 24 March 2021 between Mr. Anupam Ray, JS(PP&R), MEA and Mr. Maciej Pisarski, Director(Strategy), MFA.

II. Economic & Commercial relations

India-EU FTA was concluded in Delhi in January 2026. Poland continues to be India's largest trading & investment partner in Central & Eastern Europe. Over the period 2013-

2025, the total bilateral trade with Poland has witnessed an increase of 192% i.e. from US\$1.95 billion in 2013 to US\$ 6.36 billion in 2025. The balance of trade continues to be largely in favour of India.

The top 10 items of Indian export include: (i) Textiles and textile articles (ii) Base metals and articles thereof (iii) Products of chemical industry (iv) Machinery and mechanical appliances, electrical and electro-technical equipment (v) Footwear, headgear (vi) Transport equipment (vii) Plastic, rubber and materials thereof (viii) Prepared foodstuff (ix) Articles of stone, ceramic products, glass (x) Vegetable products. The top 10 items of Indian import from Poland include: (i) Machinery and mechanical appliances, electrical and electro-technical equipment (ii) Mineral products (iii) Base metals and articles (iv). Plastic, rubber and articles thereof (v) Products of chemical industry (vi) Optical, photographic, measuring, checking instruments etc. (vii) Transport equipment (viii) Miscellaneous manufactured articles (ix) Pulp of wood, paper, and similar (x) Articles of stone, ceramic, glass.

Investment: Indian investment in Poland has been steadily growing over the years and is now estimated over US\$ 3 billion. Indian companies are partners in the development of Poland and have created a substantial number of jobs locally, especially Indian IT companies which have invested in Poland and are estimated to employ nearly 10,000

Polish nationals. Indian companies operating in Poland include those of the IT and outsourcing sectors, such as Genpact, Infosys, KPIT-Info systems, HCL, Tata Consultancy Services, Wipro, L&T Tech and Zensar Technologies. Other Indian companies having a presence in Poland include UFLEX, Essel Propack, VVF etc. Some companies that have entered the Polish market through acquisitions include Berger Paints India, Escorts, Glenmark Pharmaceuticals, Lambda Therapeutics Research, Lumel SA and Tata Global Beverages. Total Polish investment in India is estimated at \$685 million. Major Polish companies operating in the Indian market include TZMO, Can Pack,, Polmor, SECO/WARWICK, Maflow Group etc. Billenium, an IT company, opened its office in India in 2017. EKOLOG, a firm that focuses on clean technologies, entered the Indian market in 2016 and won a tender to build an Integrated Solid Waste Management Center for the Bengaluru airport. The Polish bus-making company, Solaris – one of the leading producers of electric buses in Europe – has entered into a joint venture with an Indian counterpart, JBM Auto, to produce these kinds of vehicles for the Indian market.

Sectoral Collaboration

Mining/energy sector: Poland possesses reputed clean coal technologies and Polish public sector companies have played a substantial role in development of mining and power sectors in India. Trainee engineers from M/s Coal India Limited trainee have received training in Polish mines that specialize in intelligent mining. India and Poland signed a Memorandum of Understanding on 4 February 2019, in New Delhi to enhance bilateral cooperation in the coal and mining sector.

Agro-food Processing: Polish capabilities and advanced technologies in the food processing industry is well recognized. Polish food processing companies and entrepreneurs could participate in the Mega Food Parks being set up in India. A Joint Working Group on Food Processing has been set up.

IT and ICT: Indian and Polish IT & ICT companies complement rather than compete with one another, as manifested by the presence of a significant number of blue-chip Indian IT companies in Poland. Around 11 Indian IT companies, employing more than 10,000 professionals, are currently active in Poland and operate their Europe operation from Poland. Growth in the Polish IT industry is driven by rising incomes, investment in data networks, high levels of computer literacy support and retail hardware demand. Indian companies have gauged opportunities in Poland for over a decade and have made it a destination of choice for near-shoring operations targeted at Europe. Infosys and HCL have a strong presence in Poland.

Pharmaceutical and chemicals Sector: The chemical Industry is one of the major sectors of the Polish economy and Poland is a net importer of chemicals. Chemical products figures in top 5 exports items from India to Poland with organic chemicals taking the lead. Given Poland's strategic location, shortages in health care personnel and 25% growth in pharmaceuticals market in recent years, there are good opportunities for Indian exporters and investors. OTC drugs, food supplements and generic drugs are specific areas of opportunities. Poland is dependent on India for active substances for critical medicines and imports raw materials for the production of antibiotics - salt of erythromycin (for the treatment of respiratory tract infections, skin, urinary tract infections and postoperative infections), acyclovir (for shingles and herpes); neomycin used for wound infections and rifampicin for tuberculosis.

Textile Sector: Textile continues to be the largest segment in the Indian exports to Poland. Polish imports of textiles and textile articles from India have grown to US\$ 645 million in 2023 marking a substantial growth over the last decade. However, there exists much potential to enhance our exports in the textiles sector provided a conducive environment is created for Indian exporters.

Engineering Sector: Polish public sector companies have, in the past, played a substantial role in development of mining and power sectors in India. They have collaborated in reorganization of some Indian collieries, besides supplying mining machinery, equipment, technical know-how and training.

Sub-national Partnership: Six State-to-State cooperation/partnerships agreements, with an emphasis on economic and commercial cooperation exist between India and Poland.

III Cultural and Educational Relations: Indology: There is a strong tradition of Indology studies in Poland, with Polish scholars having translated Sanskrit into Polish as early as in the 19th Century. Sanskrit was being studied at the 600 year old Jagiellonian University in Krakow (the oldest in Poland) in 1860-61, with a Chair of Sanskrit having been established there in 1893. The Indology Department of the Oriental Institute at the University of Warsaw (established in 1932) is the biggest center for Indian studies in Central Europe. Study of Indian languages, literature, culture and Indology is also pursued at the Adam Mickiewicz University in Poznan and the University of Wroclaw. ICCR sponsored the first Central & Eastern European regional conference of Indology in Warsaw University in September 2005 in which 19 scholars from 11 countries participated. An MoU for the establishment of an ICCR Chair of Indian studies at the Jagiellonian University, Krakow was signed in February 2017 and three Indian Professors have since been appointed as ICCR

Chair Professors since the signing of the MOU. Prof. Maria Christopher Byrski, former Ambassador of Poland to India (1993-96) and Polish Sanskrit scholar received the Padma Shri Award from the President of India in March 2022 for his contribution in the field of literature and education. Prof. Byrski has taught Polish Indologists and has translated Manusmriti and the dramas of Bhasa and Kalidasa into Polish language. ICCR President Dr. Vinay Sahasrabuddhe conferred the Bharat Mitr Samman, also known as the Distinguished Indologist Award 2022, on Dr. Joanna Jurewicz, Chair of South Asia Studies, Faculty of Oriental Studies, University of Warsaw on 12 October 2023 that celebrated the Poland-India cultural confluence. ICCR conferred another Bharat Mitr Samman – Distinguished Alumni 2023 to Mr. Krzysztof Jakub Iwanek in recognition of the significant contribution in his field and outstanding contribution to the promotion of understanding, goodwill and friendship between India and Poland on December 14, 2025. Three Polish students of Hindi participated in the Visitors Programme for International Hindi students organized by ICCR in May 2023. Well-known Polish Indologists from the Jagiellonian University (Prof. Halina Marlewicz), Adam Mickiewicz University (Prof. Monika Browarczyk) and University of Wroclaw (Prof. Przemyslaw Szurek) participated in ICCR's Knowledge India International Convention in December 2023. Prof. Danuta Stasik, Chair of South Asian Studies, University of Warsaw, under Academic Visitors Programme of ICCR, visited Indian Institutions of Eminence – JNU, DU, IGNOU, Sahitya Akademi, AU & Sahitya Sammelan, Prayag, and had interactions on Hindi pedagogy and Indology.

Dr. Anna Rucinska, Sanskrit scholar and translator of Gita in Polish language participated in International Gita Mahotsav 2025 held in Kurukshetra, India from Nov.23-25. She was also a panelist on Navigating the Crossroads of Choice, Conflict and Consequences.

Yoga: Poland has over 100-year history of yoga. It is estimated that there are over 300,000 yoga practitioners in Poland, with about 1,000 yoga centers and 8,000 teachers propagating Yoga in Poland. The Association of Schools of Yoga, started in 2013 with 11 yoga schools, has now 50 yoga schools under its umbrella. The Art of Living Foundation, Brahma Kumaris and the Iyengar Yoga Association are some of the prominent associations promoting yoga in Poland. The International Day of Yoga is celebrated every year with much enthusiasm and participation at different cities of Poland.

Good Maharaja Connection: A monument, commemorating Jam Saheb Digvijaysinhji Ranjitsinhji Jadeja of Nawanagar, was unveiled in October, 2014 at the Square of the Good Maharaja, Ochota District, Warsaw, Poland. Another plaque commemorating the Valivade-Kolhapur camp at which another 5000 Polish refugees had found refuge, near the Monte Casino War Memorial was inaugurated in November 2017 in Warsaw. Eight Polish primary

and secondary schools are named after Jam Saheb, known as 'Good Maharaja' in Poland. The Maharaja had accepted more than 1000 Polish refugees, mainly children, as they escaped the depredations of the Second World War in the 1940s. The surviving Polish children have formed an Association of Poles, which meets on an annual basis in one of the major Polish cities. In coordination and with the support of ICCR, the Embassy organized a commemorative event entitled "Remembering the Good Maharajas", in the Old Orangery of the iconic Royal Lazienki park on 5 July 2022. The deputy Foreign Minister, Deputy Speaker and Governor of Mazovia represented the Polish side at this event. Representatives of the Jam Saheb of Nawanager and the Kolhapur Royal Family came from India to attend this event which witnessed participation by ICCR President Dr. Vinay Sahasrabuddhe. The first visit of a 20-member Polish youth delegation to India under the Jamsaheb Memorial Youth Exchange Programme, announced by Prime Minister Narendra Modi during his official visit to Poland in August 2024, took place from 19-27 February 2025.

Commemorating Indian leaders: A bust of Mahatma Gandhi has been placed in the library of University of Warsaw. It was unveiled in May 2002 by then Lok Sabha Speaker, Shri Manohar Joshi. Three streets in Warsaw are named after Indian leaders such as Mahatma Gandhi and another one is named after Nobel Laureate Rabindra Nath Tagore. Cities of Krakow and Lodz also have streets named after Mahatma Gandhi.

Friendship Societies: There are a number of Indo-Polish Friendship Societies that promote Indian culture and people-to-people contacts locally.

IV Consular Relations

Honorary Consulate: Since January 2018, India has an Honorary Consulate in Wroclaw and another Honorary Consulate General was opened in Krakow in August 2024. In addition to the Polish Embassy in New Delhi and the Consulate General in Mumbai, Poland has two Honorary Consulates in Kolkata and Bengaluru.

Visas: Poland has been included in the e-visa scheme w.e.f. 15 August, 2015 and a large number of Poles avail of e-visa facilities for tourism and business purpose.

Indian Community: Estimated at approximately 30,000, the Indian community in Poland consists of traders (textiles, garments and electronics) who came after the collapse of communism and professionals working with multinational and Indian companies and

software/IT businesses. Approximately 5000 students are currently pursuing studies in various universities in Poland. More than 100 Indian restaurants operate in Poland.
