2.	Name of the Position	:	Consultant in NEST Division.
3.	Period of Consultancy	:	01 (one) year The contract can be extended further depending on assessment of performance, mutual willingness and the requirement. The contract may be terminated on one month's notice from either side or on payment of one month's pay in lieu thereof. Unauthorized absence may lead to termination of the engagement.
4.	Nature of Duties	:	The selected Consultant will be required to work in the New, Emerging & Strategic Technologies [NEST] Division in the Ministry which looks after the following issues as per approved Terms of Reference: • Function as the nodal point to evolve and coordinate Indian Positions for negotiations regarding technology governance rules, standards and architecture in the multilateral or plurilateral context, including at the UN and relevant international organizations; • Assess policy and legal implications of new and emerging technologies and technology based resources; • Build policy interface with partner countries and international organizations in this context; • Assess demand driven requirements of new emerging and strategic technologies in India in collaboration with line ministries etc. and facilitate, as synapse, the interlocutor/partner interfaces; • Interface with line Ministries & eventually State governments; • Strengthen the role of Missions as the 'field synapses' in facilitating supply related chains for such technologies in this context;

			- Identify new emerging technologies with strategic import for India and undertake assessments on implications of sources and deployments of such technologies for India; - Identify and assess strategies behind deployment and operation of new and emerging technologies in India; - Strengthen India's role as a determinant player in determining the national and global perspectives on new emerging and strategic technologies, interalia; and - Any task assigned by the Head of Division.
5.	Job Location	:	Ministry of External Affairs (including Jawaharlal Nehru Bhawan/Sushma Swaraj Bhawan/Patiala House/ISIL Building/CCS Buildings).
6.	Qualifications/ Essential Criteria	:	- The applicant must be an Indian national. - The applicant must have a graduate degree in Basic Science/Professional Degrees such as Engineering and Medical Science/International Trade & Commerce/ Political Science/International Relations/Global Affairs/Management & Finance/Diplomacy. - The candidate should be in the age group of 30-40 years of age as on the last date of submission of the application.
7.	Desirable Qualifications	:	- The candidates having specialization/work experience in the field of new, emerging and strategic/critical technologies interalia including in Advanced Computing, Advanced Engineering Materials, Advanced Manufacturing, Advanced Nuclear Energy Technologies, Artificial Intelligence, Autonomous Systems and Robotics, Biotechnology and health-tech, Communication and Networking Technologies, Critical minerals, Directed Energy, Human-Machine Interfaces, Hypersonics, Networked Sensors and Sensing, Quantum Information Technologies, Renewable Energy and Green Hydrogen Generation and Storage, Semiconductors and Microelectronics, Semiconductors, Space Technologies and Systems, Telecommunications etc. will be given preference. - Extra credit will be given for experience of work in a Government Department or a reputed university or a think-tank or research organization in the above-mentioned areas and/or foreign policy or international affairs.
8.	Remuneration & Entitlements	:	- The remuneration package will be commensurate with the experience and profile of the selected candidate, subject to a maximum of Rs. 12,00,000/- (Rupees Twelve lakh only) per annum and deduction of applicable taxes. The amount of consultancy fee so fixed shall remain unchanged during the term of engagement. - The engagement will be strictly contractual and will not confer any other benefits to the selected candidates.

			• The consultant shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the regular employees of the Ministry. • No HRA shall be admissible. • The engagement of the Consultant is on full time basis. Normal working hours will be from 0900 to 1730 hrs. Working hours is subject to change from time to time. Saturdays/Sundays will remain closed as weekend off. In exigencies, he/she may be required to work beyond office hours and/or on holidays. No extra allowance or remuneration for such work is admissible. He/She shall not accept any other professional appointment, paid or otherwise in government or private sector or in any other organization of any kind during the term of engagement with this Ministry. • Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed. Leave cannot be claimed as a matter of right. Leave will not be allowed for more than 10 days at a time. Discretion is reserved to the Head of Division to refuse or revoke leave in the public interest. Leave encashment will not be permissible on unspent leave. Unspent leave will lapse on commencement of notice period. No other leave of any kind shall be admissible to him/her. In case he/she remains absent from duty beyond entitled leave, a proportionate deduction from the consolidated fee as applicable will be made. • In case the Consultant is required to travel as part of his/her duties, the Ministry will take care of his/her travel, accommodation and per-diem costs, as per Ministry's guidelines. • The selected person will be required to enter into a contract with the Ministry in a prescribed format w.e.f. the actual date of engagement as Consultant.
